008 TO DISCUSS AND MAKE A DECISION CONCERNING THE CHRISTMAS TREE

Councillor Lacy and Mrs. Lacy were thanked for making their premises available for residents after the lighting of the Parish Christmas tree. It is noted that the Christmas tree was purchased this year by Gowdall Parish Council, in previous years the Scarecrow Festival Committee have funded the event.

RESOLVED – that a member of the Scarecrow Festival will be contacted and asked what plans are in place for the 2019 Christmas Tree. Should the Scarecrow Festival Committee not be able to fund this event Gowdall Parish Council will look favourably towards taking over the funding and running of the event.

009 TO FURTHER DISCUSS SANDPIT NURSERY

The amount of rubbish is still on site. The Environment Agency are to be contacted along with Mr. Andrew Percy MP to help resolve this matter. The Environment Agency are to be asked if they could remove the rubbish and ask ERYC to recover the money from the land owners.

010 TO FURTHER DISCUSS THE PROVISION OF THE SCHOOL BUS

The situation whereby some children are able to use the facility of a school bus free and other, should they wish to use the school bus, are asked to pay is splitting the community in half. Ward Councillors Fox and Barrett were asked if they could contact the relevant officers within ERYC and point this fact out together with the fact that there are no street lights, the footpaths are bad, the road surfaces are poor and this is not a gritting route during severe weather conditions. All these elements are putting children's lives at risk. Councillor Barrett seems to think that this issue has been resolved but is willing to bring this problem to the notice of ERYC again. Councillor Fox stated that because of the severity of the situation she would personally be in touch with ERYC officers to try and get this decision overturned.

Opinions were divided as to whether or not this would be the correct way forward. It has also been noted that there is a possibility of large increase in both residential and commercial development within the immediate area. More information on this subject will filter through to the Parish Council in the fullness of time.

Notice has been drawn to all present of an Action Group regarding the reinstating of a regular direct rail service from Goole through to Leeds.

It was stated that 6 residents could receive training if they wished to take part in the Community Camera Scheme which would allow fully trained residents to monitor speed of vehicles but could not prosecute.
